**IMPORTANT EXPLANATIONS ABOUT THE DATA OWNER APPLICATION FORM
AND THE RIGHT OF APPLICATION:**

In Article 11 of the Personal Data Protection Law No. 6698 ("PDP Law"), it is regulated that personal data owners can make a request for the following matters.to be informed on whether your personal data is processed or not,

- to obtain related information on the processing of personal data,
- to be informed on the purpose of personal data processing and whether your personal data is used for the said purposes or not,
- to be obtain information on third parties (in the country or a foreign country) to whom personal data is transferred,
- to request for the correction of your personal data, if your personal

data is processed incompletely or incorrectly,

- to request erasure or disposal of your personal data within the scope of the provisions set out in Art. 7,
- to request notification of the operations carried out in compliance with subparagraphs (d) and (e) to third parties to whom your personal data has been transferred,
- to object in cases of exclusive processing of your personal data by automated systems which brings the conclusions against your side,
- to claim compensation for damages arising from the unlawful processing of your personal data.

Application Process and Finalization

Please submit your requests to us using this Data Owner Application Form in accordance with Article 13 of the PDP Law and in order to perform the necessary examination in a healthy and fast way.

Without prejudice to other methods to be determined by the Personal Data Protection Board, personal data owners submit their applications to the data controllers in writing or to their registered electronic mail address, secure electronic signature, mobile signature or previously reported to the data controller by the data subject and registered in the data controller's system. You can complete the Data Owner Application Form and send a signed copy to the addresses below using one of the above methods.
